

## 4-CENT DAG HAMMARSKJOLD

COMMEMORATIVE POSTAGE STAMP



**AVAILABLE AT YOUR LOCAL POST OFFICE** 

**OCTOBER 24, 1962** 

A special 4-cent stamp in honor of Dag Hammarskjold, the late Secretary-General of the United Nations, will be first placed on sale at New York, New York, on October 23, 1962.

The Hammarskjold stamp, designed by H. M. Sanborn of the United Nations Graphics staff, will measure 0.84 by 1.44 inches. It will be arranged horizontally and issued in panes of 50, with an initial printing of 120 million.

The stamp, portraying Dag Hammarskjold and a view of the United Nations building in New York, will be printed on the Giori presses in yellow, brown and black, on white paper.

Collectors desiring first day cancellations may send addressed envelopes, together with remittance to cover the cost of the stamps to be affixed, to the Postmaster, New York 1, New York. A close-fitting enclosure of postal card thickness should be placed in each envelope and the flap either turned in or sealed. The envelope to the Postmaster should be endorsed "First-day Covers 44 Hammarskjold Stamp." Orders for covers must not include requests for uncanceled stamps. Cover requests must be postmarked not later than October 23, 1962.

### **OPENING REMARKS**

As you can see, I've made some changes in the *Journal* this year. It's put me a little behind schedule, but I switched from my old desk-top publishing software (*Publish-It for Windows*) to *Microsoft Publisher 2002*, the latest version of the Microsoft product. The learning curve was great (coupled with very little free time) but the results should make it worthwhile.

I've made the *Journal* look more modern, and improved the fonts in an attempt to make it more readable. I hope you agree that it's a big improvement. On a "technical" level, *Publisher* gives me the ability to easily import digital images from email and the web, and electronically transmit them to Alphagraphics for printing. We should get the same great quality we've been

accustomed to, but without the hassle and loss of quality inherent in trying to print those images.

So, if you have anything to send to me for the *Journal* in general or for the *Discoveries* column specifically, and you have access to a scanner, you can just scan it (.jpg files are great) and email it to me. Of course, good, clear photocopies are always welcome, too.

Another *Journal*, including our annual auction lots, will follow this one at the end of May. Can you let me know what you think about this *Journal*?

### PRESIDENT'S LETTER

#### By Ron Walenciak

One of our members recently asked me whether he should sell his collection via the auction, or an ad in the *Journal*, or in some other manner. I get this question occasionally, and these are the thoughts I sent back to him as my response. I'd be very interested in receiving comments from buyers, sellers and dealers whether in agreement or disagreement. I can see this column becoming the foundation for a society pamphlet on "How to sell your collection"; I think we need a number of pamphlets like that to hand out at shows and provide to the membership.

Selling a collection, whether via the auction or the Journal ads, is about the same. You have to first decide to what extent you are willing to split up your collection. Generally speaking, everyone bidding is looking for a bargain, and you will find very few buyers for a complete collection; you will find more buyers for individual year sets, and some years will sell better than others. You can also specify something interesting in the year set ("1990 year set with 3 plate number coil Pages".) When the dust clears, if you put up your entire collection for sale and someone buys it, you're done; if you put up individual year sets, you might be left with a few scattered years that nobody wanted, and you may have to list them again in next year's auction, or in next quarter's Journal or you may never sell them.

Pricing a collection is the second (and toughest) part. Catalog prices, whether Scott, Brookman or *The Postal Service Guide to US Stamps*, are prices for individual Pages; you can't simply add up the price of each individual Page to get the price of a year set or an entire collection! These catalog prices are the price for a Page when the dealer had to buy a year set, for example, and selling that one Page to you will eliminate his chance of selling that year set. So, you're paying a "premium" to cover his investment and his loss of future sales. Personally, I've always felt that catalogs should show year-set prices since that

is the way we tend to look at things in the Page and Panel collecting community. Personally, I would look at previous auction prices realized, as well as dealer price lists. Nobody is going to want to pay you the same prices that the dealer lists, or even close (again, everybody wants a bargain.)

In the auction, you can set a minimum bid which will protect you from having to sell your collection for next to nothing, and not have to worry about setting the maximum you will be able to get for it. If, for example, you are willing to sell your year sets at your original cost, you can set your minimum bid to be the price you paid for those specific years. If a year is not in great demand, that might not even be reasonable. You will also have to ship your collection to Gerald Blankenship, and pay for shipping back to you if any part of it doesn't sell, so at least the first shipping amount should be factored into your minimum as well (and the 10% auction commission as well, which is paid from the seller's proceeds.)

For an ad in the *Journal* you will have to either set a concrete price, or say "make me an offer", or say "best offer over \$\$\$", but you can mention that "postage" is additional. You will have to deal individually with prospective buyers.

You can also pull certain high-value individual Pages out of the year set and sell them individually; that will bring you a better price overall, but will make that incomplete year set very hard to sell. By "high value" Page, I mean plate number coil Pages, error Pages, express mail Pages, any other Pages that were not sent to everybody as part of the subscription service, and possibly watermark varieties (although the last one requires more knowledge and time than most of us have or are willing to spend.) Another thing you could do is to purchase a "regular" Page at a low cost and replace the "high-value" Page in the

year set, thereby selling both; this is a common occurrence, where for example someone will sell all the plate number coil Pages for \$50 each and replace them with non-PNC Pages that cost \$1 each to keep the year sets intact. It's called "cherry picking" when someone pulls all the good Pages out of a collection, and you could even sell an entire collection with the note that is hasn't been cherry-picked and has ## PNC Pages, I suppose; maybe that would draw some interest from the "gamblers" in the society.

I used to list my plate number coil Pages in the Journal ads for sale with the provision that the buyer had to send me my price plus a replacement Page, which I needed to keep my collection intact. That worked out well for me, as I didn't have to be bothered with buying the replacement Page myself.

I hope these opinions help you. You might also call or write Gerald Blankenship (his address is on the 2nd page of each Journal), as he is the Auction Chairperson and would be able to give you an opinion on how to proceed with the auction. The deadline for receipt of auction lots will be listed in the next Journal, but you would have to move on that quickly, definitely in the next month or month and a half.

On an unrelated subject, I mentioned in the previous *Journal* that we would like to attend both the AFDCS Americover show and the APS Stampshow this summer. Only one member, Bill Quinn, volunteered to spend some time with us at Stampshow in Atlantic City. If any other members from the area are willing to come down, please let me know.

We still don't have anyone to serve as show coordinator for Americover in Chicago this June. While I suppose that Jim Canon might do that, as he has for all of our other Chicago shows, I would like to see if any Chicago members have any interest. You can contact Jim directly (see page 2) for information.

At last year's annual meeting, member Charles McClure asked about Jim Canon's Page & Panel slide presentation. Jim has presented it at various annual shows, and Charles had an interest in presenting it at a local stamp club meeting as well as moving it to cdrom for private viewing. Jim and Charles got together via email and Charles has provided this update:

"I used the slide show at my presentation on Souvenir Pages in February at the Rocky Mountain Philatelic Library . The presentation went over very well and they confirmed that it should make a good CD to explain what Souvenir Pages are all about."

"Currently I am working with the Colorado Macintosh users Group to determine the best format for converting the scans and the audio tape input into a format that is available to both Windows and Macintosh users. I hope to have that done this month and proceed with a trial format CD that I can send you by mid May."

"I have scanned two or three slides as a trial and they seem to appear very well in a P D F format as the result of good quality slides. As soon as I have a recommendation from my friends on the proposed format for the CD I will give you a status report by e-mail."

We'll all look forward to that report. Thanks for getting involved, Charles.

If you plans for this summer put you in Chicago in mid-July, please try to join us at the Americover show. Details on the show are printed in this *Journal*. I hope to see many of you there.

### FINANCIAL REPORT

#### By ASPPP Treasurer John Ngai

The financial report was provided by the Secretary/Treasurer to the Board of Directors for the calendar year 2001 and is provided to the membership at this time (see table below).

The society ended the year 2001 in good financial condition even though expenses exceeded income by \$1,800.58. We received less income, due to a significant drop in our membership base, with 45 members not renewing their membership, and a lower percentage of multi-year renewals.

Meanwhile, the cost to print the *Journal* increases year to year, as does mailing to all members which of course includes members up to the date of expiration who did not renew.

Included in income are multi-year renewals received in 2001; the estimated value of multi-year renewals beyond one year included in 2001 is \$1,526 whereas the prior year was \$2,030.

The estimated value of all multi-year renewals beyond one year as of year end 2001 is \$1,721.

Auction proceeds were \$691.65, as a result of the commission increase from 5% to 10% starting in 2001.

The society produced four *Journals* for the year.

Your society continues to prudently manage its income and expenses so that it can continue to produce an excellent *Journal* and mail the *Journal* at first class postage rates for prompt delivery, all without impacting membership dues at this time.

Our cash position continues to erode. Additionally, we expect another postage increase by mid-year 2002 to mail the *Journal*.

[This is an email followup from Greg Meyer regarding his recent article about 2001 Souvenir Pages and his pricing of PNC Pages. - Editor]

Dear Editor:

I mentioned briefly the cateloging of my collection and a brief discussion about pricing - which are the prices I would or feel should be paid for each item.

My pricing scheme was developed back in 1985 when having discussions with [USPS personnel] Pete Davidson, Bob Brown, Peggy Grant, John Speihs and a few others. I wanted to get a plate number on every Page with a transportation coil. I mentioned to Bob Brown that I would be willing to buy a given number of Pages if he would guarantee me a Page with plate number - like what the USPS is doing now [with mint coil strips] - buy a certain number of coil stamps to guarantee a plate number. Bob's response was that it would be labor intensive from the way things were set up then - but the USPS is using a similar idea now, called "standing orders", which I use to get just about everything issued by the post office. So ..... these ideas were not too far off the mark at the time - just ahead of the times and the way things were then done.

By the way, I made a statistical boo boo, which my statistical peers would take me to task for and which Ron caught - I left off the phrase "on the average" - that is, "buying 24 Pages, on the average", should guarantee a plate number .... if everything at the USPS is copacetic - which I

agree with Ron's concern, it probably isn't straight forward as I put it; but that is what I was and am willing to pay and thus the price I place on my inventory list. I did get a standing order of stamps yesterday which had quite a few of blank Souvenir Pages - and thankfully up through the last number, 0153, are on 2001 bond paper, show a 2001 copyright and are numbered as issued in 2001. By the way, the 0153 Page is for the "United We Stand" stamp issue in Oct 24, whereas, the 0152 Page is for the 57 cent Love Letters, issued on 19 November.

I'd like to start up our "Discoveries" column as a regular feature once again. It hasn't been printed in every issue for quite some time, as is seems the membership hasn't had much to contribute.

I would like you to report any plate numbers on coil stamps and booklet panes to me, as well as anything else you receive that seems to be a potential oddity, variety or error, or just looks "interesting" to you. Our last booklet pane plate number list was in 19xx and our last plate number update was in 19xx, so feel free to review your collections and send or email me anything you find after that date.

In our next *Journal* I hope to be able to list all known plate numbers on booklet panes so that you can compare what you have to what others have found. I've also asked Gerald Blankenship to provide an update to his Transportation Series PNC's on Souvenir Pages articles that ended in 19xx, which will give us an idea of what has been found since then, and perhaps Greg Meyer will prepare a table of plate numbers known to exist on subsequent coil stamps.

This is the only method we have of comparing our collections to see what is really out there! Please contribute your knowledge and observations to help us make it work. As part of his work on a catalog, Greg Meyer produced "comment sheets" that were to be used by members to submit potential errors and varieties. We're going to reproduce those comment sheets in the Journal. I hope once you see them you will take the time to look through your collections and report back to us. My street address and email address are printed on page 2 of each *Journal*.

Fred is going to offer this Page in our upcoming ASPPP Auction. Look for it along with all of the other auction lots in our next *Journal*.



On a different subject, ASPPP member Harry Wilson reported this interesting fact about the Spanish-American War Commemorative Panel (#534) from 1998, shown on the following page. Apparently, the Panel was originally printed with a comment in the text that the stamp was issued "... in Scottsdale, Arizona". In May 1998 the USPS mailed a corrected version of the Panel with the actual first day city, "... in Key West, Florida" along with a letter that apologized "for any inconvenience this may have caused you".

The text detail of the Commemorative Panel is shown on page 13 and the full Panel on page 14.

Harry wondered if every subscriber received both Panels? That would be our assumption since the USPS sent this letter, but I was surprised that nobody reported this earlier.




(Flag Over Porch/Jukebox/Mountain PNC Souvenir Page)




(PNC stamps close-up on Souvenir Page)

In 1823, President James that the United States would aggressively defend the Western Hemisphere against European influence. More than 70 years later, this Monroe Doctrine was put to the test.

Monroe had proclaimed

Though Spain had granted the island partial autonomy and vowed to close the prison camps used to hold Cubans, Spain's dominion hindered trade between the United

States and Cuba, and U.S. sympathy for the Cuban rebels was growing

On February 15, 1898, the battleship U.S.S. Maine, stationed in Cuba's Havana harbor to help protect U.S. interests, was shattered by an explosion. Over 250 people were killed. Though the explosion's source was unknown, U.S. newspaper headlines and, soon, many angry U.S. citizens, blamed Spain.

On April 11, President McKinley asked Congress to send the nation to war against Spain. McKinley asked for only 125,000 volunteers to fight the war. But it had been 30 years since America's last significant call to arms—the Civil War—and a new generation of young men was eager for combat. One million men, including Theodore Roosevelt, responded to McKinley's call.

Over the next few months, U.S. forces destroyed a Spanish fleet in Manila Bay, in the Philippines and a Spanish ship that tried to cross their blockade in Cuba's Santiago harbor. By August, a truce had been signed and this brief war was over.

This 32-cent stamp commemorates the centennial of the Spanish-American War. It shows a line drawing of the Maine and, above it, a banner with the nation's battle cry, "Remember the Maine." This stamp was designed by Richard Sheaff and issued on February 15, 1998, in Scottsdale, Arizona.

### **MEDAL OF HONOR**

#### By Gerald Blankenship

In the book of John, Jesus declares, "Greater love hath no man than this, that a man lay down his life for his friends" (John 15:13). Congressional Medal of Honor recipient Michael Edwin Thornton exemplified this declaration while serving in the United States Navy in Vietnam.

Born March 23, 1949, in Greenville, South Carolina, Mike Thornton struggled through high school because of reading difficulties due to dyslexia. At the time, educators knew little about this problem; subsequently, students were labeled "slow." We now know that these students are usually very bright, and Thornton has proved to be no exception. Following high school graduation, he joined the Navy and qualified for the SEAL program. One of only twelve men out of the 129 men who entered the program, he was assigned to SEAL Team One in 1968. Once a SEAL team was formed, they would live together, both in Vietnam and in the United States. This would foster camaraderie in the men.

A few months later, Thornton was deployed to Vietnam for his first six-month rotation. His mission was to gather intelligence and disrupt the Vietcong infrastructure. Locating and interrogating province chiefs, they were often involved in fierce firefights.

During this first tour, Thornton's skill and prowess was noted among the men. Completing his first mission, he returned home for further training in intelligence, foreign weapons, demolitions, and advanced medicine. In 1969 he was again deployed to Vietnam: the mission was the same - disrupt the VC infrastructure.

One of his harrowing tales involved a mission to kidnap a Vietcong province chief. Hiding under rice bags, as he floated down a river on a sampan, he was signaled by a slight kick from a cooperating chief that the target of the investigation was on the boat as they went through one of the many checkpoints. Thornton rose to his feet and killed the chief and his bodyguards. Responding to the fire, the VC began to barrage them with bullets as Thornton sped away, aided by air-support.

Thornton's third tour in Southeast Asia began in 1970 and consisted of covert operations that involved "body snatches" and training the Thai people to do recon missions. At this point in his career, he had already turned down two Purple Hearts stating, "I didn't think I had been sufficiently wounded.... A Purple Heart should be given when someone has significant and lifethreatening injuries." He would get the opportunity to meet this criterion on his fourth tour.

By the time his fourth tour in July of 1972 began, most Americans were leaving Vietnam. However, the war effort was still a big reality for many American service men. Thornton's mission this time was to rescue downed pilots and do recon missions. It was on one of the recon missions that he earned his Congressional Medal.

He and fellow SEAL Tommie Norris were ordered to see how suitable the river would be for an amphibious attack. In an interview, he relates, "a successful operation could mean going back to the peace negotiations and using the land won as a bargaining chip. We understood the significance of this mission when we left."


Of course the rest is a piece of history recorded here for you to read. What the citation does not tell you is that not only did Thornton save Norris's life that day, in an act of bravery which earned him the Medal of Honor, but also Norris later became a Medal of Honor recipient himself. They attended each other's ceremonies.



#### THORNTON, MICHAEL EDWIN

Rank and organization: Petty Officer, U.S. Navy, Navy Advisory Group. Place and date: Republic of Vietnam, 31 October 1972. Entered service at: Spartanburg, S.C. Born: 23 March 1949, Greenville, S.C. Citation: For conspicuous gallantry and intrepidity at the risk of his life above and beyond the call of duty while participating in a daring operation against enemy forces. PO Thornton, as Assistant U.S. Navy Advisor, along with a U.S. Navy lieutenant serving as Senior Advisor, along with a U.S. Navy lieutenant serving as Senior Advisor, accompanied a 3-man Vietnamese Navy SEAL patrol on an intelligence gathering and prisoner capture operation against an enemy-occupied naval river base. Launched from a Vietnamese navy junk in a rubber boat, the patrol reached land and was continuing on foot toward its objective when it suddenly came under heavy fire from a numerically superior force. The patrol called in naval gunfire support and then engaged the enemy in a fierce firelight accounting for many enemy casualties before moving back to the waterline to prevent encirclement. Upon learning that the Senior Advisor had been hit by enemy fire and was believed to be dead, PO Thornton returned through a hail of fire to the lieutenant's last position; quickly disposed of 2 enemy soldiers about to overrun the position, and succeeded in removing the seriously wounded and unconscious Senior Naval Advisor to the water's edge. He then inflated the lieutenant's lifejacket and towed him seaward for approximately 2 hours until picked up by support craft. By his extraordinary courage and perseverance, PO Thornton was directly responsible for saving the life of his superior officer and enabling the safe extraction of all patrol members, thereby upholding the highest traditions of the U.S. Naval Service.
